

NOTIFICATION

G. O. (P) No. 163/2009/Home. Dated Thiruvananthapuram, 16th October, 2009.

S. R. O. No. 864/2009.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (Act 19 of 1968), the Government of Kerala hereby make the following rules to amend the Kerala Chemical Examiner's Laboratory Subordinate Service Special Rules, 1997 issued in G. O. (P) No. 271/97/Home dated the 11th November, 1997 and published as S. R. O. No. 885/97 in the Kerala Gazette Extraordinary No. 1535 dated the 11th November, 1997, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Chemical Examiner's Laboratory Subordinate Service (Amendment) Special Rules, 2009.

(2) They shall be deemed to have come into force on the 11th November, 1997.

2. *Amendment of the Rules*.—In the Kerala Chemical Examiner's Laboratory Subordinate Service Special Rules, 1997,—

(1) In rule 2, in category 1, after the words "Technical Assistant" the words "or Serological Assistant" shall be added;

(2) In the Table under rule 3,—

(i) in column (1), in category 1, after the words "Technical Assistant", the words "or Serological Assistant" shall be inserted;

(ii) in column (2), against category 1,—

(a) in item (iii) for the figures and symbol "3:1" the figures and symbol "1:2" shall be substituted;

(b) after item (iii), the following item shall be inserted, namely:—

"(iv) If qualified hands are not available for promotion, the vacancies shall be filled up by direct recruitment subject to the condition that the aforesaid ratio will be restored at the earliest opportunity".

(3) In the Table under rule 5, in column (1), in category 1, after the words "Technical Assistant" the words "or Serological Assistant" shall be inserted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The revised Special Rules, for the various posts in the Subordinate Services of the Chemical Examiner's Laboratory Department were issued in G. O. (P) No. 271/97/Home dated 11-11-1997 published as S. R. O. No. 885/97 in the Kerala Gazette

Extraordinary No. 1535 dated 11th November, 1997. The category of Serological Assistant was originally included in the Special Rules framed for the department as per G. O. (Rt.) No. 1170/76/Home dated 11-5-1976. But it was not included in the revised Special Rules since in the Pay Revision Orders of 1989 the scale of pay of Serological Assistant and Technical Assistant were made identical and thus the post of Serological Assistant ceased to be a promotion post of Technical Assistant. However, there exist posts of Serological Assistant in the Chemical Examiner's Laboratory Department and the Kerala Public Service Commission has appointed candidates later. Hence it has to be specified in the Special Rules that these category of posts are to be deemed as one and the same in every respect. Government have decided to issue necessary amendments to the Special Rules.

The notification is intended to achieve the above object.
